

# Bealtaine Hero Award 2022

## Deadline: 5pm, Friday March 4<sup>th</sup> 2022

### Information for applicants

Age & Opportunity's Bealtaine Festival wishes to recognise two innovative grass roots arts projects through the **Bealtaine Hero Award**. We invite applications from individuals and / or organisations who wish to create an exciting new festival event (which may be online, blended or in-person)\* to be presented during the Bealtaine Festival 2022. We especially invite members of marginalised or underrepresented groups to apply.

\*Please refer to the section on Health & Safety in this document regarding blended and in-person events.

### About the Bealtaine Festival

Bealtaine is Ireland's national festival which uniquely celebrates the arts and creativity as we age. The festival is run by Age & Opportunity, the national organisation working to improve the quality of life for us all as we age. Bealtaine is at the centre of Age & Opportunity's Arts programme and celebrated its 25<sup>th</sup> anniversary in 2020. In 2022, we continue our theme of

**In(ter)dependence** – inspired by our centenary as a sovereign nation, but also in recognition of our interdependence with each other and the natural world. Covid-19 and in particular its impact on older people, has underlined the natural and human ecosystem of dependence and connection.

## Bealtaine Hero Award

The call for applications to the **Bealtaine Hero Award** is open to local, community based groups (or individuals) who wish to submit proposals for an event that offers an ambitious, creative and experimental invitation to their community this May, and that celebrates the spirit of the festival. All art forms and event types will be considered, however non-arts events will not be considered (please see appendix for examples of arts and non-arts events).

## Call for Applications

Age & Opportunity invites applications from event organisers for one of two Bealtaine Hero awards.

**Two awards of €500 will be made to the two successful applicants.**

### Application Process:

Those wishing to apply for the **Bealtaine Hero Award** should complete the application form. Any supporting documents should be submitted separately.

### Eligibility Criteria:

The project/event should be led by a community organisation or individual with a track record of organising community activities. The project/event should include at least one professional artist\* working in any art form. Artists may apply but only in partnership with a community organisation. (The award

is not intended for government-funded organisations such as local authorities, although community groups that are working in partnership with or in receipt of funding from local authorities are eligible.)

\*For the purposes of the award, we are defining a professional artist as someone who is either making a living from or attempting to make a living from their work, and/or who is a member of a professional representative body such as: Visual Artists Ireland, Film Director's Ireland, Association of Irish Composers etc.).

### Selection Criteria:

Applications will be assessed according to the following criteria and applicants should pay special attention to these when completing the application form:

- Track record of the event organiser;
- An event which is ambitious in form or content, experimental, innovative or challenging;
- An event which involves at least one professional artist (working in any art form – visual artist, theatre artist, musician, etc.);
- An event which is clearly achievable in the timeframe outlined;
- An event which clearly resonates with Age & Opportunity's mission and/or target audience.

Applications should be submitted to the Arts Administrator, Eva Griffin [arts@ageandopportunity.ie](mailto:arts@ageandopportunity.ie) no later than **5pm, Friday March 4<sup>th</sup> 2022**.

Any queries relating to the award may also be directed to Eva by email, including requests for assistance with filling out the application form.

We aim to communicate final decisions by late March 2022. Should a large volume of applicants be received, this timeline may be adjusted to provide

additional time to review all applications. All applicants will be kept notified of any changes or updates.

## Conditions of the Award

### The event organiser will:

- Produce all aspects of the event to include but not be limited to booking artists, promoting the event, etc.;
- Produce all technical aspects that may apply to an online event;
- Prominently credit Age & Opportunity and Bealtaine as a co-producer / supporter of the event;
- Commit to the timeframe of May 2022 for the event;
- Commit to some financial or benefit in kind contribution to the event;
- Provide key materials to Bealtaine such as: high quality image/photo for marketing purposes, promotional text as well as making themselves available for PR opportunities;
- Provide a short report on the event after the fact including high quality images/photos of the event;
- Ensure that all guidelines and policies relating to Health & Safety are adhered to if any part of the event is to be held in person, particularly regarding Covid-19 (please refer to Health & Safety information in this document).

### Age & Opportunity will:

- Provide a platform for the event through the Bealtaine Festival;
- Provide PR support through the Bealtaine Festival (the event will need to also have its own PR plan);
- Provide a financial contribution of €500. (There are two awards available.)

## Health & Safety

Applicants should understand our commitment to holding events in line with current government guidelines around Covid-19 and our own Health & Safety policy and Child and Vulnerable Adult Safeguarding protocols. Risk assessments will be carried out for any in-person events and relevant documents such as safety statements will be required from the successful applicant and any artist involved.

## Equality, Human Rights, and Diversity

Please note that Age & Opportunity welcomes applications from all communities, and particularly encourages artists from underrepresented communities to apply

## More Information

### Age & Opportunity

Age & Opportunity is the national organisation that provides a range of opportunities for older people who want to get more involved in arts and culture, sport and physical activity, civic engagement and personal development.

We work with local communities and organisations across the country to run a range of programmes and activities in three key areas:

## Appendix 1 – What is and isn't an arts or culture event?

Bealtaine considers any event that involves an artistic medium or relates to wider cultural concerns as an arts or culture event.

### Examples of eligible art forms are:

- Dance
- Drama/Theatre
- Film
- Literature
- Music
- Opera
- Poetry
- Traditional Arts (traditional music, craft or storytelling)
- Visual arts (painting, sculpture, installation, textiles, etc.)
- Circus Arts

### Examples of cultural events that include an arts aspect:

- Food related event - a coffee morning with live music or poetry.
- Historical event – a walking tour with a scene recreated by an actor.
- Reminiscence event – a storytelling event or visual art workshop based on reminiscences.

### Types of events may include:

- An artist talk or interview
- A guided tour of an arts and culture space/exhibition
- A workshop on particular art form or craft
- A performance or screening

- Commissioning an artist to make new work

**Examples of non-arts events:**

- Sporting events
- Table quizzes
- Yoga/pilates/meditation
- An event that has no artistic or creative element

Please note that the above is not exhaustive.

If you are unsure if your event is an arts/creative event, check to see does it contain one of the art forms above or is there an artist (visual artist, theatre artist, musician, etc.) involved in the event?
