

# National Arts in Nursing Homes Day (May 19<sup>th</sup> 2023) Award 2023

Deadline: 5pm, Friday  
February 24<sup>th</sup> 2023



## Information for applicants

Age & Opportunity's Bealtaine Festival, in partnership with Nursing Homes Ireland, wish to recognise three outstanding arts projects through the **National Arts in Nursing Homes Day Award**.

We invite applications from care settings who wish to facilitate their residents' artistic and creative expression by organising interactive and engaging arts workshops, sessions and events led by professional artists. These care settings

will aim to create an exciting and suitable Bealtaine project that celebrates their residents arts and creative talents, culminating in a festival event (which may be online, blended or in-person)\*. This will be presented as part of **National Arts in Nursing Homes Day** that will take place Friday 19<sup>th</sup> May during the Bealtaine Festival 2023. It presents an opportunity to bring together residents, families, care staff and artists to promote the arts in your care setting, to support residents in expressing their creative talents and to take joy from a creative arts initiative.

## About Bealtaine Festival

Bealtaine is Ireland's national festival which uniquely celebrates the arts and creativity as we age. The festival is run by Age & Opportunity, the national organisation working to improve the quality of life for us all as we age. Bealtaine is at the centre of Age & Opportunity's Arts programme and celebrated its 25<sup>th</sup> anniversary in 2020. In 2023, we continue our theme of **In(ter)dependence** – inspired by our centenary as a sovereign nation, but also in recognition of our interdependence with each other and the natural world. Covid-19 and in particular its impact on older people, has underlined the natural and human ecosystem of dependence and connection. While this theme often provides a useful framework for Bealtaine events, care settings are not required to refer to it.

## About Nursing Homes Ireland

Nursing Homes Ireland (NHI) is the representative organisation for the private and voluntary nursing home sector in Ireland. Over 400 private and voluntary nursing homes are members of NHI, providing specialised care in a 'home from home' to circa 25,000 people in communities across Ireland. Circa 40,000

people are employed in the private and voluntary nursing home sector. Care is at the heart of NHI, which supports its members to deliver the very highest standards of clinical, health and social care. Person-centred care that promotes resident talents and interests has an integral role to fulfil in supporting the health and wellbeing of nursing home residents.

## National Arts in Nursing Homes Day Award

The Age & Opportunity and Nursing Homes Ireland **National Arts in Nursing Homes Day Award** aims to encourage and support access to the arts for the residents of care settings and to support care settings to participate in Bealtaine. The award also aims to demonstrate how the arts can contribute to the overall well-being and care of residents in care settings.

Participation might involve planning a new arts project/initiative/event (which may be online, blended or in-person) for their setting and must involve at least one professional artist. An ideal project would consist of a number of artist engagements with residents before a final celebration event. The **National Arts in Nursing Homes Day Award** is not expected to cover the total costs of the event (which must be contributed to by the care setting).

**One award of €1,000 and two awards of €500 will be made to the three successful applicants.**

The first **National Arts in Nursing Homes Day** was held in May 2021 and saw 144 care settings around the country get involved in arts activities to celebrate the spirit of Bealtaine. We hope to see even more care settings take part each year.

Through participating in **National Arts in Nursing Homes Day**, each care setting will have the opportunity to raise public awareness about their work and to refocus attention on the vibrant and creative life of their residents while bringing a professional artist into their setting. **National Arts in Nursing Homes**

**Day** will also be an opportunity to celebrate the sometimes hidden, but hugely valuable work of creating a space where all residents can express themselves meaningfully through arts experiences.

## Call for Applications

Age & Opportunity and Nursing Homes Ireland invites applications from care settings for one of three **National Arts in Care Homes Day** awards.

### Application Process:

Those wishing to apply for the **National Arts in Care Homes Day Award** should complete the application form. Any supporting documents should be submitted separately and sent with the application form. This includes:

- Artist's CV and 3 x examples of their work

Applications will be assessed according to the following criteria and applicants should pay special attention to these when completing the application form:

### Eligibility Criteria:

- The project/initiative/event should include at least one professional artist\* (working in any art form – visual artist, theatre artist, musician etc). Activity coordinators already working in the nursing home will not meet this criteria.
- Professional artists may apply but only in partnership with the care setting.
- Care settings\*\* must financially contribute to the project/initiative/event or provide some in-kind supports.

\*For the purposes of the award, we are defining a professional artist as someone who is either making a living from or attempting to make a living from their work, and or who is a member of a professional representative body

such as: Visual Artists Ireland, Film Director's Ireland, Association of Irish Composers etc.).

Additionally, for the purposes of the award we are defining a project/initiative/event as an arts project lead by a professional artist within a care setting that involves the residents and staff and takes place over the course of days, weeks or months (as above). It is envisioned that this project then leads to a celebration event in the spirit of Bealtaine, to take place during May 2023. Please see appendix 1 for more information on what qualifies as an arts initiative/event.

\*\*In this instance we define care settings as nursing homes or day care centres.

### Selection Criteria:

- A project/initiative/event that is **ambitious** in form or content, experimental, innovative or challenging.
- A project/initiative/event that is focussed on the **engagement** of the residents and visitors to the centre and takes place over time.
- A project/initiative/event that clearly **resonates** with Age & Opportunity's and Nursing Homes Ireland's missions and/or target audiences.
- Track record of the care setting/event organiser in developing creative or arts projects/working with artists.
- Track record of the professional artist as demonstrated by CV and 3 examples of work.
- A project/initiative/event that is clearly **achievable/feasible** in the timeframe outlined.

Applications should be submitted to the Arts Administrator, [arts@ageandopportunity.ie](mailto:arts@ageandopportunity.ie) no later than **5pm, Friday February 24<sup>th</sup> 2023**.

Any queries relating to the award may also be directed to by email.

We aim to communicate final decisions by March 6<sup>th</sup> 2023. Should a large volume of applicants be received, this timeline may be adjusted to provide additional time to review all applications. All applicants will be kept notified of any changes or updates.

## Conditions of the Award

### The care setting/artist will:

- Produce all aspects of the project/initiative/event to include but not be limited to booking artists, promoting the event, etc;
- Produce all technical aspects that may apply to an online initiative/event;
- Prominently credit Age & Opportunity/Bealtaine and Nursing Homes Ireland as co-producers/supporters of the project/initiative/event;
- Commit to the timeframe of May 2023 for the event;
- Commit to some financial contribution or in-kind supports to the project/initiative/event;
- Provide key materials to Bealtaine and Nursing Homes Ireland such as: high quality image/photo for marketing purposes, promotional text, as well as making themselves available for PR opportunities;
- Provide a short report on the event after the fact including high quality images/photos of the event;
- Ensure that all guidelines and policies relating to Health & Safety are adhered to if any part of the event is to be held in person.

### Age & Opportunity and Nursing Homes Ireland will:

- Provide a platform for the event through the Bealtaine Festival;

- Provide PR support through the Bealtaine Festival, (the event will need to also have its own PR plan) and Nursing Homes Ireland's communications;
- Provide a financial contribution of €1,000 or €500. (There are three awards available; all funded by Age & Opportunity and NHI).

## Health & Safety

Applicants should understand our commitment to holding events in line with current government guidelines around Covid-19 and our own Health & Safety policy and Child and Vulnerable Adult Safeguarding protocols. Risk assessments will be carried out for any in-person events and relevant documents such as safety statements will be required from the successful applicant and any artist involved.

## Equality, Human Rights, and Diversity

Please note that Age & Opportunity welcomes applications from all communities, and particularly encourages artists from underrepresented communities to apply

### Age & Opportunity

## Appendix 1 – What is and isn't an arts or culture event?

Bealtaine considers any event that involves an artistic medium or relates to wider cultural concerns as an arts or culture event.

### Examples of eligible art forms are:

- Dance
- Drama/Theatre
- Film
- Literature
- Music
- Opera
- Poetry
- Traditional Arts (traditional music, craft or storytelling)
- Visual arts (painting, sculpture, installation, textiles, etc.)
- Circus Arts

### Examples of cultural events that include an arts aspect:

- Food related event - a coffee morning with live music or poetry.
- Historical event – a walking tour with a scene recreated by an actor.
- Reminiscence event – a storytelling event or visual art workshop based on reminiscences.

### Types of events may include:

- An artist talk or interview
- A guided tour of an arts and culture space/exhibition
- A workshop on particular art form or craft
- A performance or screening

- Commissioning an artist to make new work

**Examples of non-arts events:**

- Sporting events
- Table quizzes
- Yoga/pilates/meditation
- An event that has no artistic or creative element

Please note that the above is not exhaustive.

If you are unsure if your event is an arts/creative event, check to see does it contain one of the art forms above or is there an artist (visual artist, theatre artist, musician, etc.) involved in the event?
