Information for applicants

Age & Opportunity believes that the arts is particularly important and beneficial as we age, and has long been a supporter of older artists.

The Bealtaine Festival is 28 years old in 2023 and is Ireland's only festival dedicated to celebrating the arts and creativity as we age. Part of our work involves supporting the participation and representation of older people in the arts, including supporting and giving a platform to older artists. Similarly, we devise professional development training for artists across generations, as well as supporting arts networks and best practice through partnerships with Dance Ireland, Visual Artists Ireland, Irish Theatre Institute, First Music Contact, Irish Writers Centre and more.

Professional Development Artist Award

Age & Opportunity recognises that artistic practice is a lifelong journey and demands continued upskilling and training.

The Age & Opportunity **Professional Development Artist Award** aims to celebrate lifelong learning by encouraging and supporting *professional older artists who wish to further develop their career and practice through specific activities to meet their development needs (training, research, etc.). **It is not intended to support formal third or fourth level education. The award also aims to publicly demonstrate the value of older artists.**

The following further guidelines are taken from the Arts Council of Ireland's Professional Development Award Guidelines.

Examples of Professional Development opportunities might include:

- Creative development supports, such as participation in workshops, specialist courses, master classes, research projects, residencies, coaching/mentoring, attendance at conferences/seminars;
- Career development supports, such as strategic and/or financial planning, promotional, presentation or digital skills, proposal writing.

Please note that there is a separate Emerging Artist Award for those who wish to simply continue their practice.

Notes on terms

* While there is no one definition of a professional artist, we require that applicants are a member of a professional representative body such as: Visual Artists Ireland, Film Director's Ireland, Association of Irish Composers or equivalent, or that their CV clearly shows a professional career. For this award in particular, we are requesting that applications are a member of a professional representative body.).

One award of €1000 will be made to the successful applicant.

Call for Applications

Application Process:

Those wishing to apply for Age & Opportunity **Professional Development Artist Award** should complete the application form, as well as sending a CV, a sample of work (no more than 3 images/videos/files) and a confirmation letter from an organisation or individual in respect of a training/upskilling opportunity.

Eligibility Criteria:

The Age & Opportunity Professional Development Artist Award will be offered to a professional artist, (working in any artform) aged 50 + based in the Republic of Ireland who:

- has membership of a professional representative organisation or equivalent (i.e. Visual Artists Ireland, Film Director's Ireland, Association of Irish Composers etc.);
- is working in any artform and based in the Republic of Ireland;
- has a demonstrated intention to develop their practice.

Selection Criteria:

Please note, applications will be assessed by an Age & Opportunity appointed panel.

- Strength of track record indicated through your track record/CV;
- Artistic quality and ambition as evident through your **supporting material**;
- Demonstration of the need for training and development
- Demonstration of how this opportunity/course in particular will benefit your creative practice
- Quality of training/development opportunity (as evidenced by information on the opportunity, trainers etc.)

Applications should be submitted to the Arts Administrator arts@ageandopportunity.ie no later than **5pm, Friday March 24th 2023**.

Any queries relating to the award may also be directed to by email.

We aim to communicate final decisions by April-May 2023. Should a large volume of applicants be received, this timeline may be adjusted to provide additional time to review all applications. All applicants will be kept notified of any changes or updates.

The successful recipient will be required to sign a short contract form that asks for adherence to general Health & Safety advice.
